### **THE JACKSON TOWNSHIP ROAD LEVY**

The Jackson Township Road Levy expires this year, 2013, and will be on the November ballot as renewal Issue 32 with no new taxes.

This extremely important levy has been the necessary backbone of Jackson Township Highway Division resurfacing and roadway improvements in our ever-growing community and traffic. The significant benefit derived from leveraging the road levy funds in gaining OPWC (Ohio Public Works Commission) and other grants has been very effective. Over the last ten years \$82,140,000 has gone into Jackson Township Highway projects for traffic improvements with the Jackson share or match being only \$13,938,500, or 17 percent. Your Jackson Township Board of Trustees has been very active and responsible in managing your tax dollars. The reduced operating funds, higher expenses in all operations, and the recognized resident financial constraints demand difficult and sometimes unpleasant decisions. The Trustees and departments are dedicated to strong and judicious financial management.

### **2013 CONSTRUCTION & HIGHWAY ACTIVITIES Hills & Dales - Woodlawn/Dressler:**

Widening to five lanes has taken place during the 2012 and 2013 construction seasons. A large storm sewer was installed and intersection improvement at Woodlawn/Dressler was accomplished in this heavy commercial area.

This was a joint project with the Stark County Engineer utilizing an OPWC (Ohio Public Works Commission) grant and local funding.

Frank Avenue Phase II: Widening to four lanes from Bob O'Link to Applegrove and tapering back to two lanes just south of Strausser was well underway by midsummer. The project will improve the intersection at Huckleberry and the intersection and traffic signal operations at Applegrove. This is also a joint project with the Stark County Engineer, which has received an OPWC grant and local money. Completion is expected in the late spring or early summer of 2014.

**Resurfacing:** 12.93 miles of Jackson Township resurfacing was accomplished to maintain the allotment community high standards. Once again, grinding street surfaces and curb and catch basin repair, prior to resurfacing, has increased the road levy expenditure. The numerous allotments built in the 1990's and early 2000's are increasing the requirement for new surface and road levy funding.

**Curbing Replacement:** 8,085 feet of deteriorated curbing was replaced in our sixth consecutive year of curbing improvement. This work precedes resurfacing and has been a beneficial use of the road levy funds.

**Road Restriping:** Road levy funding also provided for restriping of 40 miles of Jackson Township busy roadways in 2013. Bright new centerlines and edge lines, stop bars, and turn arrows make driving safer both day and night.

### **DRAINAGE, MOWING, SWEEPING, SIGN MAINTENANCE, PATCHING, SNOW & ICE CONTROL**

These year-round maintenance efforts have kept our reduced road crew busy. Nature's growth and destruction, normal wear and tear, accidents, and vandalism never take a vacation.

**New Equipment:** Two new 2014 dump trucks equipped with plows and salt spreaders have replaced the two oldest plow trucks. The newest technology of salt distribution control and salt treatment is now in use for economic and maximum operational effectiveness of these very expensive winter safety applications.

**Snow & Ice Control:** Winter operations in the Highway Division are always the most difficult. Long hours starting in the middle of the night, difficult weather driving conditions, and continuous driver concentration required to miss mailboxes and place snow where it does not offend, are sometimes challenging for our drivers. Stakes will once again be placed in the difficult roadway locations to help our drivers avoid problems with your home frontage.

With the weather the country and the State of Ohio have been experiencing and Jackson Township being the victim of an actual tornado April 28, 2002, the Jackson Fire Department wants to insure that our residents are educated in "Emergency Preparedness".

Most disasters are natural disasters, the result of some force of nature, such as tornadoes, hurricanes, and floods. Some natural disasters can be predicted, such as hurricanes and severe winter storms, while others, such as tornadoes and earthquakes, happen with little or no warning.

Some disasters are the cause of human actions, intentional or unintentional. A disaster plan will help with safety, security, and comfort.

Regardless of the type of disaster, there are things you can do to prepare. Contact your local Red Cross chapter, visit the FEMA website, or Ready.gov to make sure you are aware of the potential for natural disasters in your community. After you have identified the types of disasters that could strike where you live, create a family disaster plan that can apply to any type of disaster – natural, unintentional, or intentional.

## PREPARE AN EMERGENCY SUPPLIES KIT

Disaster can occur suddenly and without warning. They can be frightening for adults, but they are traumatic for children if they don't know what to do when these events occur. Children depend on daily routines. When an emergency disturbs their routine, children can become nervous. In an emergency, they'll look to parents or other adults to help.

How parents react to an emergency gives children an indication on how to act. They see their parents' fear as proof that the danger is real. A parent's response during this time may have a long-term impact. Including children in the family's recovery plans will help them feel that their life will return to normal.

Families should prepare an emergency supplies kit and develop a plan. Practice your plan so that everyone will remember what to do in an emergency. Everyone in the home, including children, should play a part in the family's response and recovery efforts. Remember: make the plan simple so everyone can remember the details.

Have your children create their personal pack. Have them include things like their favorite book or stuffed animal. These familiar things will help keep them comfortable during an emergency:

- Change of clothes
- Favorite toy
- Blanket & Books
- Paper, pencils and crayons

## EMERGENCY SUPPLY LIST

- Water - one gallon per person per day for drinking and sanitation - store 3-day supply
- Ready-to-eat food, canned juices, comfort/stress foods - at least a 3-day supply
- Battery-powered or hand-cranked radio and a NOAA weather radio, and extra batteries for both
- Flashlights and extra batteries
- First aid kit
- Non-prescription medication
- Prescription medications, contact lenses and supplies, denture needs
- Infant formula and diapers, if you have an infant
- Water and pet food if you have pets
- Moist towelettes, garbage bags and plastic ties for personal sanitation
- Plastic sheeting and duct tape to shelter-in-place
- Wrench or pliers to turn off utilities
- Can opener for food
- Aluminum foil
- A jacket or coat, hat and gloves
- A complete change of clothing including long pants, long sleeve shirt, and sturdy shoes stored in a waterproof container.
- Sleeping bag or warm blanket for each person
- Rain gear
- Mess kits, paper cups, plates and plastic utensils
- Cash or traveler's checks, change
- Paper towels
- Matches in a waterproof container
- Paper, pencil
- Personal hygiene items
- Soap
- Disinfectant and household chlorine bleach
- Important family documents such as copies of insurance policies, identification and bank account records in a waterproof, portable container. Remember to include emergency contact numbers.
- Passport, bank account numbers, credit card account numbers and companies

## JACKSON TOWNSHIP FIRE PREVENTION BUREAU



The Jackson Township Fire Department Fire Prevention Bureau, in addition to conducting inspections in businesses throughout the Township, also provides training and information on fire safety.

Over the summer, fire extinguisher training was completed at several medical facilities, which included “hands-on” demonstrations of proper use of a fire extinguisher. In addition, a Life Safety In-Service Day was held for 125 employees of a local health center.

The Fire Prevention Bureau is required to stand-by for all fireworks demonstrations – in addition to the annual July 4th fireworks, they also oversaw the Community Celebration and the Jackson Belden FoodFest and Fireworks.

They also participated in the Relay for Life and attended Ohio Pools Customer Appreciation Day and Buehler’s “Touch a Truck” Day.

Car seat inspections/installations are held on the first Monday of each month; a total of 33 car seats were installed between June and August.



The Fire Prevention Bureau members also attend Continuing Education Classes that are required to maintain their certifications. These include the annual Ohio Arson School and monthly Fire Data Exchange Association meetings as well as participating in trainings held in other jurisdictions.

## WINTER DRIVING

Driving in bad weather is not something you accomplish by passing your driver's exam; it requires learning. Learning and experience. I have seen a number of accidents that appear to have been caused by inexperienced drivers. When road conditions are hazardous, it is best to stay off the roads whenever possible.

The Ohio Department of Transportation has advised us that they will not salt some of the state routes as they have in the past because of the increased price of salt.

It is my belief that during non-peak hours, some state routes may not get the attention they have in the past, which means more difficult driving conditions. If you must drive, please observe the following driving tips.

## SAFE WINTER TRAVEL

Winder conditions call for different driving tactics. Ice and snow, take it slow – slower speed, slower acceleration, slower steering, and slower breaking. Give yourself extra time to reach your destination safely. It's not worth putting yourself and others in a dangerous situation just to save time.

- Drive with your headlights on.
- Drive for conditions. Don't get overconfident with four-wheel drive. It won't help you stop any faster.
- Winter road conditions often result in longer stopping distances. Drivers should allow additional room between their vehicles and others.
- Slow down when approaching intersections, off ramps, bridges or shady spots. These all have the potential to develop black ice that makes driving hazardous.
- Avoid abrupt actions while steering, braking or accelerating to lessen the chances of losing control of the vehicle.
- Look farther ahead in traffic. Actions by other drivers will alert you to problems and give you extra time to react.
- Trucks take longer to stop. Don't cut in front of them.
- Avoid using cruise control or overdrive. Don't let your car make a bad decision for you.
- Stopping on snow and ice without skidding requires extra time and distance. If you have anti-lock brakes, press the pedal down firmly and hold it. If you don't have anti-lock brakes, gently pump the pedal. Either way, give yourself plenty of room to stop. Source: [www.wedot.wa.gov/winter](http://www.wedot.wa.gov/winter).

# Group Buying Power Works for Electricity Too

## JACKSON TOWNSHIP GOVERNMENTAL ELECTRIC AGGREGATION

Thanks to governmental aggregation, residents and small businesses in Jackson Township have access to a beneficial electric program that provides savings every month on their electric bills.

The aggregation program provides participants with guaranteed savings on their electric bills through a percent savings off the utility's generation rate. This means that regardless of the rate your utility would charge you for electric generation, the price you pay through the Jackson Township aggregation program will always be lower. To find out the amount of your discount, please call 1-866-636-3749. Have a recent copy of your electric bill handy.

Governmental aggregation, which was passed by Jackson Township voters in 2010, allows community leaders to form aggregated buying groups to purchase electric generation on behalf of their citizens. By bringing citizens together, the aggregation gains group buying power and typically can negotiate a better price with the supplier than each aggregation group member could have negotiated individually.

Jackson Township selected Akron-based FirstEnergy Solutions, one of the nation's largest electric generation suppliers, to serve the residents and small businesses in the community served by Ohio Edison and AEP Ohio.

Your local electric utility will continue to be responsible for the delivery of power to homes and businesses, and will continue to read your meter, maintain poles and wires, and restore power after an outage.



## JACKSON PARKS INFORMATION AND WINTER HOURS

Jackson Township residents have eight parks with approximately 240 acres, including:

### Jackson Township Parks:

1. North Park..... 7660 Fulton Road
2. South Park..... 4811 South Park Drive
3. Joseph E. Fisher..... 5891 Lake O'Springs Avenue
4. Nelson Keck..... 7500 block of Wales Avenue
5. Edward and Mary Zink..... 38th Street and Michael Drive
6. Stuhldreher Street Fields..... Stuhldreher and Hills and Dales
7. Strausser Elementary Park..... 8646 Strausser Street
8. Crystal Springs Bridge Park.... 4400 block of Erie Avenue

North Park is open from 6:00 a.m. until 10:00 p.m. now through November 30. Beginning December 1 through February 28, North Park will be open sunrise to 8:00 p.m.

When visiting any of our other parks, such as South Park, Crystal Springs Bridge Park, Edward & Mary Zink Park, Joseph E. Fisher Park, Nelson M. Keck Park, Strausser School Fields, and Stuhldreher Street Fields, the hours of operation are dawn to dusk.

For your walking pleasure, the red walking track in the North Park is marked with yellow hash marks at every one-tenth of a mile. The outside loop of the track is 1+ mile.



**DO NOT LEAVE PETS UNATTENDED - PLEASE REMEMBER TO CLEAN UP AFTER YOUR PET.**

Pets are permitted in all of our parks **except** the North Park. While on any other park grounds, lots, streets, drives or any other park facilities, all pets shall be controlled by a leash connected with a person or fixed object.

## PARK PAVILION RENTALS

Beginning January 2, 2014, you can turn in your pavilion application forms to reserve any of the four Jackson Township park pavilions. Reservations will not be taken over the phone and are accepted on a first-come, first-served basis. You must pick up your permit approximately one week prior to your reservation. For pavilion availability, you may contact the Jackson Township Parks at 330-832-2845 or view open dates on the park web page at [www.jacksontownship.com](http://www.jacksontownship.com). For Jackson Township residents, business owners, and non-profit organizations, there is no charge to use the pavilions. The charge is \$10 per hour for non-residents and for-profit organizations and companies.

## HOUSEHOLD HAZARDOUS WASTE

Leftover household products that contain corrosive, toxic, ignitable, or reactive ingredients are considered to be household hazardous waste. Products such as

paints, cleaners, oils, batteries, and pesticides contain potentially hazardous ingredients that require special care when you dispose of them.

When determining how to dispose of household hazardous waste, **READ THE LABEL**. Some hazardous materials indicate proper disposal techniques on their labels. If disposal directions are not present on the label of a material known to be hazardous, the label will indicate contents, solubility, or corrosive/reactive potential through the warnings or cautions on the container.

## ALWAYS ATTEMPT TO USE ALL OF ANY HAZARDOUS MATERIAL.

If you have more than you require, maybe a neighbor is in need. Although the complete use of a product is wise, give leftover products to others only if the material is in its original container with the label intact. Any "precautionary" information that may have accompanied the container should be provided to the new owner. A wise purchase of only the amount you will require will reduce the hazardous waste you generate.

## DO NOT DISPOSE OF ANY HOUSEHOLD HAZARDOUS MATERIAL DOWN THE DRAIN.

Do not dump anything hazardous down a sink, floor drain, or toilet. This also includes letting hazardous materials run down the storm sewer system (draining an automobile's oil into the gutter system or excessive water runoff from a pesticide treated yard).


## RECYCLE WHENEVER POSSIBLE (BATTERIES, OIL, ETC.).

## DO NOT MIX HAZARDOUS WASTES.

Never combine leftover household hazardous wastes into one container. Incompatible products might react, ignite, or explode, and contaminated household hazardous waste might become un-recyclable.

There are many hazards associated with the improper disposal of household hazardous wastes. Improper disposal of household hazardous wastes can include pouring them down the drain, on the ground, into storm sewers, or in some cases putting them out with the trash. Certain types of household hazardous waste have the potential to cause physical injury to sanitation workers, contaminate septic tanks or wastewater treatment systems (if poured down drains or toilets), and present hazards to children and pets if left around the house. The dangers of such disposal methods might not be immediately obvious, but improper disposal of these wastes can pollute the environment and pose a threat to human health.

To avoid the potential risks associated with household hazardous wastes, it is important that people always monitor the use, storage, and disposal of products with potentially hazardous substances in their homes.

### OPEN MONDAY THROUGH SUNDAY – DAWN TO DUSK

Our highly regarded resident drop-off area in South Park on Fulton Drive has continued to be the largest in Stark County. Jackson Township loads out this material nearly daily to provide room for the many backing and dumping vehicles and trailers. The Stark, Tuscarawas, Wayne Joint Solid Waste District provides the debris removal trucking operations.

Fall leaves are upon us as the busiest and most crowded drop-off time of the year. Residents should carefully secure their loads in transit. The highway crews routinely must retrieve these loose droppings from the roadways. Also, residents are requested to back up as close as possible to the debris pile when unloading to preserve the open area for vehicle maneuvering.

## ZONING BOARDS AND THEIR DUTIES

Two zoning boards that are vital to effective implementation of township zoning are the zoning commission and the board of zoning appeals. The establishment of a zoning commission and a board of appeals is a requirement of the Ohio Revised Code for administration of a township zoning resolution. Both boards are comprised of five regular members and an alternate that are appointed by the township trustees. All board members must be township residents. Regular members are appointed for staggered five-year terms. Alternates are appointed for one year. Applications to serve on the zoning boards are solicited annually in the month of November and appointments or reappointments are made only after all applicants have been interviewed by the Jackson Township Board of Trustees. All board meetings are open to the public. Meeting agendas are available on our website at [www.jacksontwp.com](http://www.jacksontwp.com).

making its decision. A majority vote of the Township Trustees is required to deny or modify the zoning commission's recommendation.

## NEW BUSINESS PROPOSED IN JACKSON TOWNSHIP

The Hyatt Hotel will be coming to Jackson Township and will be located at northwest corner of Whipple and Everhard Road. The 67,980 sq. ft. building, which has a valuation of \$6,300,000, will have 105 rooms and an indoor swimming pool.

The Zoning Commission meets the third Thursday of the month as needed.

## ZONING COMMISSION

The function of the zoning commission is to consider and make a recommendation to the Jackson Township Board of Trustees in connection with any request to rezone property from one zoning classification to another zoning classification (map amendment), or any request to change the zoning resolution (text amendments). The zoning commission or the Board of Trustees may also initiate a map amendment or text amendment. A recommendation from the Stark County Regional Planning Commission to approve, deny, or modify the request must be considered by the zoning commission at a public hearing prior to

## BOARD OF ZONING APPEALS

The purpose of the Jackson Township Board of Zoning Appeals (BZA) is to act upon appeals from a decision or determination of the zoning inspector, to consider applications for variances, and the granting of conditional use permits. The board may also grant approval to allow an expansion of a non-conforming use over 25 percent, and a change from one non-conforming use to another non-conforming use.

The Board of Zoning Appeals usually meets on the second and/or fourth Thursday of the month depending on the number of hearings scheduled.

## PROPER DISCHARGE OF SWIMMING POOL WATER

**Drain Your Pool in an Approved Manner:** When swimming season is over, pool owners need to be careful of how and where they discharge swimming pool water when they lower the level of their pool. The discharge of chlorinated swimming pool water directly into a waterway or into a storm sewer is prohibited.

The storm sewer system (which includes ditches and pipes) was designed to handle runoff from rain and snow only. The water is not treated before it is discharged into area creeks and rivers. If the water contains chlorine, it can be very toxic to fish and other aquatic plants and animals. Therefore, residential swimming pool water must be dechlorinated before being discharged. *Do not allow pool water to discharge to a septic system.*

**Dechlorinate Pool Water Before Discharging:** Reduce the chlorine in the pool water to undetectable levels before draining it. The simplest method is to stop adding chlorine to your uncovered pool and wait. Sunlight will naturally dissipate the chlorine within a few days. It can also be reduced by adding a chemical called sodium thio-sulfate, which is available at pool stores (always follow the directions). Monitor the chlorine level with a swimming pool chlorine test kit. When there is no longer any detectable chlorine in your swimming pool it is safe to discharge the water. When discharging the water, allow it to flow over a grassy area at a slow rate to allow for some filtration of the water.

**Saltwater Swimming Pools:** The recent increase in popularity of saltwater swimming pools has caused many to examine the best method for discharging this type of water. At this time, it is still undecided. The bottom line is that some smaller water bodies can be more severely affected due to the higher salinity of the discharge water. Please exercise caution.
