- A) Such use shall be conducted entirely within the dwelling unit and no use of any accessory building or yard space shall be permitted.
- B) Such use shall be clearly incidental and secondary to the use of the dwelling for dwelling purposes.
- C) Such use shall be owned and operated solely by the person or persons residing in the dwelling unit.
- D) One (1) unlighted nameplate not more than four (4) square feet in area announcing the name and home occupation shall be permitted. A permit shall be required for construction and erection of such sign.
- E) Such use shall not create a nuisance by reason of noise, odor, dust, vibration, fumes, smoke, electrical interference, or other cause.
- F) Such use shall not generate more than four (4) cars at a time.
- G) Parking spaces shall be provided off-street for any traffic generated by such use.
- H) There shall be no retail sales of item not produced on the property.
